This is written to you and your associates on behalf of Mandalay Associates Limited Partnership, of which I serve as managing general partner, owner of the 386 unit, 12 story apartment building known as 880 Mandalay.

During April, 1991, the property suffered the effects of a severe and unpredicted storm off the Gulf of Mexico which literally hit the west side of the building due to its beach front location. You will recall that 120 apartments were damaged, some so severely that occupancy was precluded; the two story windows and interiors of the five large function rooms were destroyed; all three roofs required replacement, and major work was required to repair the six cooling towers, car ports, the parking lots and landscaped areas. Balconies and the exterior skin of the building required significant rehabilitation and resurfacing.

Within 24 hours of the storm, you and your colleagues were on site, emergency repairs had commenced and our insurance carriers were fully advised and involved.
